

McCABE BOOKING FORM & CONDITIONS

All bookings are subject to our full booking conditions which appear on our website www.mccabe-travel.co.uk. A copy of these can also be e-mailed or posted to you on request. By asking us to make your booking, you confirm you have had access to and agree to the full booking conditions which you should read.

Your contract will be with McCabe Travel Limited trading as McCabe Pilgrimages. This contract comes into existence when we dispatch our confirmation invoice to the person who makes the booking.

The booking conditions provide for the payment of cancellation charges if you cancel or fail to make payment when due. They also include limitations and exclusions of our liability to you. For international travel by air, sea or rail, our liabilities are limited and excluded as if we were a carrier within the applicable international convention or EU regulation (for example, the Montreal Convention, the EC Regulation on Air Carrier Liability and the Athens Convention). A surcharge may be payable in limited circumstances where certain costs increase after booking.

Cancellation Should you or any member of your party need to cancel your booking once it has been confirmed, you must immediately inform us. Your notice of cancellation will only be effective when it is received in writing by us at our offices. As we incur costs from the time we confirm your booking, the following cancellation charges will be payable. Where the cancellation charge is shown as a percentage, this is calculated on the basis of the total cost payable by the person(s) cancelling excluding insurance and amendment charges. Insurance and amendment charges are not refundable in the event of cancellation.

57 days or more	Deposit
56 to 29 days	45%
28 to 8 days	75%
Less than one week	100%

Depending on the reason for cancellation, you may be able to reclaim these cancellation charges (less any applicable excess) under the terms of your insurance policy. Claims must be made directly to the insurance company concerned.

Flight Delays In the event of any flight delay or cancellation at your UK or overseas point of departure, the airline is responsible for providing such assistance as is legally required by the Denied Boarding Regulations. The ferry, tunnel or rail operator is similarly responsible in relation to any delayed or cancelled sea crossing or international rail departure. Except where otherwise stated in our brochure or on our website, we regret we cannot provide any assistance in such circumstances other than information and advice to the extent we are in a position to do so.

The Foreign and Commonwealth Office publishes regularly updated travel information on its website which you are recommended to consult before booking and in good time before departure.

ATOL Protection Many of the flights and flight-inclusive holidays we organise are financially protected by the ATOL scheme. Data Protection Please be assured that we have measures in place to protect the personal booking information held by us. This information will be passed on to the principal and to the relevant suppliers of your travel arrangements. The information may also be provided to public authorities such as customs or immigration if required by them, or as required by law. Certain information may also be passed on to security or credit checking companies. If you travel outside the European Economic Area, controls on data protection may not be as strong as the legal requirements in this country. We will only pass your information on to persons responsible for tour travel arrangements. This applies to any sensitive information that you give such as any disabilities or dietary requirements. (If we cannot pass this information to the relevant suppliers, we will be unable to provide your booking. In making this booking, you consent to this information being passed on to the relevant persons). Full details of our Data Policy are available on request.

Passports British citizens require a British passport in order to travel to the destinations we feature. A new passport can take up to 6 weeks to obtain. Current visa and compulsory health requirements (if any) for British passport holders are shown in the brochure. Requirements may change.

ABTOT Protection As a member of the Association of Bonded Travel Organisers Trust Limited (ABTOT), McCabe Travel Limited has provided a bond to meet the requirements of the Package Travel, Package Holidays and Package Tours Regulations 1992. In the event of McCabe Travel Limited's insolvency, protection is provided for non-flight packages commencing in and returning to the UK and other non-flight packages excluding pre arranged travel to and from your destination. Please note that packages booked outside the UK are only protected when purchased directly with McCabe Travel Limited. In the above circumstances, you may claim a refund if you have not yet travelled; or continuation of your holiday if you have already travelled.
