For several hundred years, St. Giles has stood proud on the edge of the village of Farnborough, overlooking the rolling fields and woodlands of Kent. It has withstood some violent storms in its time and has suffered structurally on occasions. Twice the tower has been severely damaged and once the roof was totally destroyed.

From early times, St. Giles has been a place of comfort to a great many people, both regular worshippers and occasional visitors. The very young have been accepted into the Christian faith at the font near the West door. Many a bride has been joined in the sight of God to her betrothed facing the beautiful stained glass windows above the altar and many have found comfort when having to say farewell to a loved one in bereavement.

St. Giles is a church with a long and happy history, a warm and welcoming building which makes a return visit a must for many who have entered its doors. Many people of note have had connections with St. Giles such as Dr. Thomas Young, who helped to interpret the hieroglyphics on the Rosetta Stone. Urania Boswell, the Gypsy Queen, died on 24th April 1933 and is buried in the churchyard.
