## ST. GILES AND ST. NICHOLAS

These two churches serve a parish of some 21,000 people, which stretches from Farnborough Park and Locksbottom to the boundary with Green Street Green.

Both churches have lively congregations. Each congregation is responsible for the management of its own business.

# THE PAROCHIAL CHURCH COUNCIL (P.C.C.)

Members of the P.C.C. are elected at the Annual General Meeting to represent either St. Giles or St. Nicholas Church for a term of three years, after which they stand down.

The whole P.C.C. meets together four times a year to consider a parish wide agenda. At the other meetings, the agenda alternates between the concerns of the two congregations. There are six St. Giles agenda meetings, and six St. Nicholas agenda meetings. P.C.C. members are free to attend all meetings, but have particular responsibility for the agenda of the congregation they represent.

The P.C.C. is made up of two clergy, two wardens, deputy wardens, two secretaries, two treasurers and elected representatives for each Church.

# QUALIFICATIONS OF PERSONS TO BE CHOSEN OR ELECTED BY ANNUAL MEETINGS

The qualifications of a person to be elected a parochial representative of the laity to either the parochial church council or the deanery synod are that:

- (a) his/her name is entered on the roll of the parish;
- (b) he/she is an actual communicant;
- (c) in the case of election to the parochial church council, he/she is of sixteen years or upwards, and in the case of his/her election to the deanery synod, he/she is of eighteen years or upwards.
